This drug formulary has been developed jointly between the Pharmacists and Doctors in the Trust, with input from Primary Care. It has been developed to promote quality, cost-effective prescribing both in the primary and secondary care sectors. The formulary will be regularly reviewed and enhanced to include links to local and national guidelines.

With many medicines having more than one indication, the formulary has been indexed under the drug therapies linked to each NICE Clinical Guideline (CG) and associated Technology Appraisal (TA)
